**RULES**

1. All female entrants 18 or older must be in good standing with the GA 500 Club, Georgia State USBC and USBC. Members must show USBC and Georgia 500 Club cards upon registering. New members will be accepted provided they present proper verification of having bowled a scratch 500+ series in sanctioned league or tournament play and provided bowler has not bowled three (3) or more scratch 600+ series in the year prior to the current tournament – **see rule 8.**
2. The tournament will be a 4-game series with handicap being based on 90% of the difference of bowler's average and 200 pins. The winner will be determined by adding the scores of the highest 3 games plus handicap.
3. Entrants **shall use the highest 2024-25 USBC winter yearbook average of 21** games or more. If there is no previous winter average, use the highest average from the current summer season, provided 12 or more games were bowled by August 30<sup>th</sup>, 2025. If no previous winter or summer average, entrant must bowl scratch. Rules 319a-2 and 319e do not apply.
4. Average verification must be provided when entering or you will bowl scratch. Average printouts from USBC (bowl.com) are preferred. A signed verification from your League Secretary or Association Manager is acceptable. Rule 319a-3 regarding reporting incorrect average will apply.
5. Prize fund will be returned 100% - one award for each 5 entries, with special \$10 awards given to the bowler with high scratch game, high scratch series (best 3 of 4 games), and high scratch series for the first 3 games bowled. A bowler may qualify for only 1 of the special awards. All prize monies will be paid within 30 days of the tournament ending. Rule 319d does not apply.
6. All entrants must sign the official score sheet. Any errors must be reported within 24 hours.
7. In the event of a tie, co-champions will be declared, with the first and second place prize money being divided between them. For all other ties, the prize money for the tied places will be added and divided equally.
8. USBC rules prevail. The Executive Board will decide anything not covered herein. **Individuals who have bowled three (3) or more 600+ scratch series in sanctioned league or tournament play within the year prior to the current tournament (September 14<sup>th</sup>, 2024 to present) will not be eligible to enter this tournament or club.** If you bowl a 600+ scratch series in the first 3 games of this tournament it counts toward disqualifying you from GA 500 Club membership.
9. Reserve entries are due by midnight, September 1st, 2025. On site entries will be accepted up to one (1) hour prior to the tournament session on a first come, first served basis. Renewal dues of \$2.00 for 2025-2026 should be paid even if you are not entering the tournament. If you previously left the GA 500 Club because of the 600 series rule or haven't renewed your membership for 2 years you must pay \$6 to be reinstated in the Club.
10. Tournament games may not be re-bowled except as authorized by the Executive Board when scores are irretrievably lost in an automatic scoring device.
11. Premature termination of the tournament brought about by war, national emergency, or emergency causes relating thereto or from fire, natural disaster or any other reason beyond the control of the GA 500 Club shall cause, to the extent required thereby, all advertised prizes guaranteed or otherwise, to be prorated in accordance with the number of entrants who have bowled in the respective event up to the time of such termination.

**PLEASE PRE-REGISTER** for the tournament. If you must register on site, bring **PROOF OF AVERAGE** (average printout from USBC (bowl.com), or a signed statement from league secretary or association manager is acceptable). **FAILURE TO PROVIDE AVERAGE VERIFICATION WILL RESULT IN YOUR HAVING TO BOWL SCRATCH.** In addition, no prize money can be paid to you without verification. **If you are joining the GA 500 Club on site, you must bring proof of having bowled a scratch 500+ series** verified by league secretary or association manager.
